Speed is an issue for the department. Sheriff Lenzner will try to place an officer in Cecil on Friday nights with our 8 hours of coverage. Speed is up all over the state. Cleaning out the Right of Ways in the Village-There was a complaint from the residents of the property that was cleaned. Some residents are happy that the cutting was done. The owners are unhappy that their plants were cut down. There is a fence on the property, it is unknown if the fence on the property is in the right of way. They are asking if this would be possible. It looks that a conditional use permit may be possible for an Airbnb/office.

B Korth-4 Seasons-the garbage carts -how many carts, Lids will be blue, black, Cascade is the company, the carts are black, the village will not apply for a grant, Storage of extra carts would be where? The carts can be stacked 12 carts high. The board has decided to order 325 until B Korth runs the route and gives us a number. Then the board will order the carts.

Problems with campground water because the campers are watering the grass, the water was left running in the fish house. Great Lakes was here to pull sewer pumps and change oil in pumps.
