## Village of Cecil Board Meeting Minutes 05/20/2025

The meeting was called to order at 4:00PM by Pres J Nolan

The Pledge of Allegiance was recited.

Motion made by A Kallies to approve and deviate from the agenda, seconded by P Westcott, motion carried.

The meeting is in compliance.

Public Comment-Ken VanDePlas-Walleyes for Tomorrow-Fish spawning between Loon and Washington Lakes, 1200 fish were netted in 5 days, 2 Walleyes were found in the Red River that had been tagged in Loon Lake, 9.3 million fry were released. An electrical box will be placed by Walleyes for Tomorrow for their use, they will put a lock on it to prevent accidental disconnection. Muskies are being researched now, in 5 years this may something that Walleyes for Tomorrow may be approached by the state.

Deacon Todd-St Martin's Catholic Church- A Procession is planned for June 22, a Sunday, from around 10:30-11:30AM to the park and put up a tent for a celebration. Also a comment in regards to the dump station at the park not being available to residents.

April Minutes correction-Motion made by B Weier to strike the wording following the Kayak launch repurposing, seconded by C Wallrich, motion carried, 5 ayes, 2 nay.(Westcott, Kallies)

Motion to accept the Treasurer's report and Minutes with correction by C Wallrich, seconded by D Sperberg, motion carried, all ayes.

Landshark's-Scott – Landshark's- June 28<sup>th</sup> Celebration-Motion made by A Kallies to extend the noise curfew on June 28<sup>th</sup> for the Landshark Celebration to 12:00Midnite, seconded by P Westcott, motion carried, all ayes.

Golden Sands Street Closure-Veterans'Golf Outing-Motion made by A Kallies to allow street closure of Nabor Road on July 19<sup>th</sup> for approximately 4 hours, seconded by M Hendricks, motion carried, all ayes.

Maintenance Report-Dewey will be off over the Holiday Weekend, Tyler will be taking readings, someone will be needed to check on the campers over the weekend. Docks have all been installed, he requested that someone else be hired to take out the docks and plowing for the winter. Road bids are in, Paladin has the bids, and cannot file for a grant until that time they

become available in July. Warrington Ave repairs are being started 30 feet from the intersection, which will be done at a later time. Curb and gutter will need to be done on this repair. Ditching has been done along the golf course. Painting along streets was done. Portable generator has been placed next to the sewer system for the storms. Two bids were received for the sewer sealing, Great Lakes and Summit. Great Lakes has no warranty, Summit is sealing the entire chimney with a ten year warranty, Great Lakes only sealed the top two feet. An email was sent to Summit for cost on the vac truck listed in his quote. This will be discussed next month.

Campers are wondering what to do with their grass clippings. They will be directed to take their clippings to the yard waste site on Saturday. There are 3 boat lifts left on the park site. Fire & Ice still have their toilet at the park. Dewey had to rescue a pontoon, a camper ran over the electric box and water line, the camper himself fixed the water, the electrical box will be capped off and charged to the camper. Bill Uelmen has decided to give up mowing in the Village, as well as the Yard Waste Site.

Motion made by A Kallies to go into closed session, seconded by P Westcott. Motion carried

Motion made by A Kallies to offer Mark Ziarkowski based on application reference and discussion, a part time position with the village, with a probationary period of 90 days, seconded by B Weier, motion carried, 5 ayes, 2 abstensions(Sperberg, Nolan)

KerberRose Capital Asset Threshold-Motion made by C Wallrich to increase the capital asset to \$5000, seconded by A Kallies, motion carried, all ayes.

Ordinance Changes-P Westcott supplied notes to the board on short term rentals, B Weier supplied info from Kewanee Co, along with Ordinance from Oconto Co received last month, this will be on next month. Discussion on ordinance for Pickerel Creek.

Correspondence-DNR emails-A Kallies-contacted Scott Koenke in regards to the email and a discussion was held with Mr Koenke and also P Westcott, additional sites in the creek can be added with the application and supporting required documents for a permit costing approximately \$703 and a review of the entire property which may reduce the amount of total dock sites allowed. This app is filed with the DNR.

Culvert repairs-30"x34'-\$2691.53, \$2449, \$1975.45 with an endwall, B Weier got prices on culverts. Motion made by P Westcott to purchase the culvert for Lemke Street, seconded by M Hendricks, motion carried, 1 abstention(Weier)

Road Bids-Next Month-Act 12 Weier-money may be available for lawn mowing. Cutting Edge lawn mowing would mow at \$400 per week and not at all if not growing. July is when we can apply for the grant.

Fireworks-Boom Hut-Robert VanHulst-is asking to extend the days from Memorial to Labor day rather than the middle of June to the middle of July. The camper is there for storage and storm

safety. He does stay overnight in emergency. Motion made by C Wallrich to amend the motion on Boom Hut Fireworks Sales to allow sales from May 23<sup>rd</sup>, 2025 until September 1<sup>st</sup>, 2025, seconded by M Hendricks, motion carried, all ayes.

Motion made by A Kallies to approve Fireworks permit for Crazy Craigs, seconded by M Hendricks, motion carried, all ayes.

Motion made by A Kallies to approve Transient Merchant application for Blaser's, John Johnson, seconded by P Westcott, motion carried, all ayes.

There are a few licenses missing from the Liquor Licensing as well as Operator Licenses.

Motion made by C Wallrich to counter the Town with \$2500 for the remainder of this year, and \$3500 next year for use of the Yard Waste Site with supplied manpower for Saturday, seconded

by M Hendricks.motion carried. All ayes. Explanation: The season is 7 months long, with 5 months remaining. \$3500 divided by 7 is \$500 per month, 5 months remaining x \$500 is \$2500.
