Maintenance Report-Tyler will be taking care of stations on June 26-29 while Dewey is on vacation. Roads will be bid on in July. Sewer stations have been a problem for the last month, Crane has been here to clean and repair the Wallrich Station. Tri County will be contacted for a price to pump the stations rather than Great Lakes, J Nolan believes that Tri County will be more reasonably priced. Summit will be contacted to reline the 6 sewer manholes plus 2 others. Dewey has poured the cement for the generator pad on Meyer St Station, WE Energies will be here on June 30th to hook up the gas, then Lisowe and Radtke will be contacted. A grinder will be investigated for the sewer system for the rag issues occurring in the pumps. Scottie Schmidt has been hired for the Yard Waste Site. PortaPottie still in the park from Fire on Ice. St Martins will in the park this weekend, Dewey will set up the electrical. The John Deere Tractor tires are bad, the brush hog in under repair, the tractor is used approximately 50 hours a year. A roll bar will be investigated for the tractor. The brooms are worn out for the street sweeper, there is an aftermarket company that makes them, M Hendricks will check into this for maintenance. Paul Huntington will also be contacted to see if he has used brooms. The red truck starter was replaced.
